The panel gave its valuable suggestions to introduce a new paper "Investment management in place of Indirect taxes in SEM V for U.G. and also to add some additional topics in ^{the paper} "Investment management". Topics like:- Valuation of Equity & Bond, Introduction of Investment, risk & return, SEBI regulations to be included in the Ist unit, whereas few more topics to be added ^{included} in the IInd unit of this paper, i.e. Regulatory framework of SEBI & stock market operations. The panel also suggested to include some topics like fundamental Analysis of Security, Mutual fund and valuation of shares in the IIIrd unit.

The panel also suggested to add assessment of firm, Individual and company in the paper of Income tax in SEM V for U.G.

(The panel also gave its valuable suggestions to introduce a new paper "Goods and Service tax" in place of complete Indirect taxes in SEM V for the U.G students and same to be added for P.G students in SEM V.

The panel also gave its valuable suggestions to include GST as a topic in the GST Network, GST council, Overview of GST tariff and HSN code. GST Portal - its introduction, GST Eco-system and GST to be in the IIIrd unit of Indirect taxes (Sem.VI). Also to include The Union territory goods & Services tax Act 2017 in Unit II of Indirect taxes (Sem.VI). and at last Custom Act to be included in the Unit I of Indirect taxes (Sem.VI) U.G.

The panel also suggested to apply the same changes of Indirect taxes to P.G. in Sem IV

The panel gave its valuable suggestions to apply the practical implementation of E-filing up of 20 marks in Income tax (SEM.VI) U.G.
