Sister also read out the letter from Dr. Manju Singh, Joint Secretary UGC dated 29 th April 2015 and addressed to the Registrar, MDS University Ajmer informing the University about UGC's decision to Confer/Grant Fresh Autonomous status to Sophia Girls College for a period of six years w.e.f. 2015-16 to 2020-2021.

Sister Janet, the Secretary of the College proposed increasing the College fee gradually in order to pay the salaries as well as for other expenses of the College. After considering the fact that the state-aid has been withdrawn			
	from the institution since 2011, the members duly approved the proposal.
